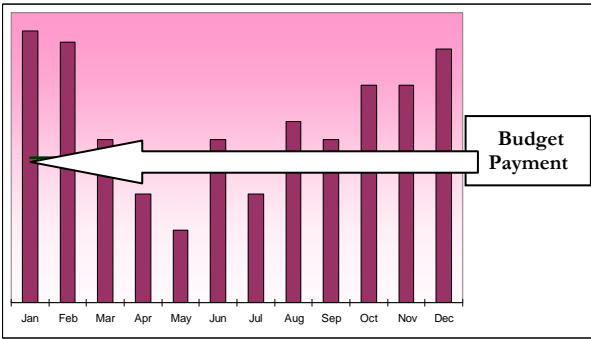

## **Benvenuti Has Better Oil**

At Benvenuti Oil we pride ourselves in offering only premium heating oil products and now we have improved every gallon! All our heating oil is now protected with a fuel treatment additive to protect your tank and the oil contained in it.

- **Fuel Stability**- Prevents your fuel from degrading.
- **Dispersants** – Extends the life of your fuel filter, cleans lines and removes deposits from your tank.
- **Corrosion Protection**- Prevents fuel and water from damaging your tank, filter and lines.
- **Anti-Foam**- Allows for greater fill levels, maximizing homeowner's storage capability.
- **Water Control**- Contains a special blend of water dispersants and dehazers to allow for gradual water removal.

#### **Retail Credit Agreement**

1. **PURCHASES:** We will deliver, subject to availability, fuel oil at our established price, which is determined at the time of delivery. Deliveries will be made to you at the address shown on this application, on an automatic delivery basis, unless otherwise noted on this application, according to a weather controlled degree day system. A meter printed delivery ticket will be left or mailed each time a delivery is made. You agree to accept each delivery and pay the full amount on each delivery ticket within 20 days.
2. If you maintain a service contract with us or if you require service calls, repairs or maintenance, which are not covered by the service contract, you may also charge the price of the service contract, service calls, repairs or maintenance to your account. If you do so you agree to pay the full amount due within 20 days from the time service contract, service calls, repairs or maintenance is made.
3. **MONTHLY STATEMENT:** If you have a balance in your account we will send you a monthly statement. It will show your purchases, the SERVICE CHARGE, and the date the payment is due.
4. **SERVICE CHARGES:** Unless you paid the previous balance shown on your monthly statement in full by its payment due date, a SERVICE CHARGE will be added to your purchases account from the date of the purchase and these SERVICE CHARGES will be computed by multiplying the past due balance by the following monthly periodic rates: 1 ½% on balances over 30 days, which is an ANNUAL PERCENTAGE RATE OF 18%. Minimum monthly service charge of \$1.00 per month.
5. **Default and Collection Costs:** You will be in default if you do not pay a balance on time, file for bankruptcy, or make an assignment for the benefit of creditors. Default means we refer collection of the balance to a lawyer or collection agency, you will pay attorney's fees, collection agency's fees and court costs.
6. **Irregular Payment and Delay in Enforcement:** We can accept later payments or partial payments, or checks and money orders marked "payment in full" without losing any of our rights under this agreement. We can also delay in enforcing our rights under this agreement without losing them.
7. **Amendment or Changes:** We can change this agreement including SERVICE CHARGES and the ANNUAL PERCENTAGE RATE, at anytime, provided we give you at least 30 days notice, before the beginning of the billing period in which the change becomes effective
8. **Cancellation:** You can cancel your account at anytime on advanced written notice. You agree to remain responsible for payment for all purchases made on or before the advanced written notice is received. We also have the right to cancel your account without notice if you fail to make payments on time.
9. **Account Suspension:** We reserve the right to suspend oil deliveries and service work if you fail to keep your account in good standing, fail to make payments on time, or are unable to access your property safely.
10. **Liability:** Benvenuti Oil is not responsible for damage or loss caused by equipment failure under any circumstances. We do our best to keep your equipment running and we do our best to keep track of your oil usage, but sometimes equipment fails or your usage changes due to circumstances unknown to us. Therefore, you are ultimately responsible for your heating equipment and tank levels.
